NO RECOMMENDATION OR INFLUENCE WILL BE ENTERTAINED TO REINSTATE THE STUDENT.
- Severe action will be taken on those who disfigure or damage the school property. Cost of repair or replacement with penalty charges will be levied.
- Children should not leave the school premises without obtaining permission from the Class Teacher and Principal.
- 9. Students should respect all members of the Staff and be obedient to them.
- Every student must take part in physical training and games unless exempted on medical grounds in advance.
- Parents are expected to check with concerned Teacher / Principal with regard to their son's / daughter's
  performance. They must collect their child's report card in person, during every "Open Day" notified in the
  School Calendar / Notice Board unless otherwise directed.
- 12. Parents are expected to pay the fee on or before the due date mentioned in the fee schedule failing which the student is liable to be sent home.
- 13. Students should work sincerely throughout the year.
